The sealed bids must be delivered on due date & time as mentioned above, which will be opened on the same day in the office of Executive Engineer B&R Division near Eidgah Konodass Gilgit in presence of bidders who choose to attend at the same address.

Authorization/attorney will be entertained subject to provision of Judicial stamp paper for specific work duly signed by owner and attested from the Public Notary.
