Terms and conditions:

- 1. Sealed bids may be submitted to the undersigned before closing date and time, which will be opened by the committee as per above mentioned date and time in presence of relevant participants.
- The contractor/supplier must have adequate supply/stock in Ghanche and the firm will be bound to supply demanded items at the agreed price for current financial year 2024-25.
- 3. Sealed envelope containing application, mandatory documents and schedules for pre qualification must be submitted before the closing date and time accordingly.
- 4. The copy of bid security/call deposit (refundable) in shape of bank draft by a scheduled bank in the name of Deputy Commissioner Ghanche must be attached with prequalification proposal. Applications without call deposit will be rejected.
- 5. Only registered firms/dealers/suppliers/contractors will be considered.
- Any item not mentioned in the schedule of items must be supplied to the authority at the market rate of the time of supply order.
- 7. Conditional, ambiguous and incomplete applications will be rejected.
- 8. Minimum 2 years of experience in the relevant field and all other necessary documents/certificates must be attached with pre-qualification documents.
- 9. All kinds of taxes applicable(if any) will be inclusive in the bid price and bound by the bidders.
- 10. The competent authority reserves the right to accept or reject any or all bids as per relevant guidelines/provisions of ppra.
- 11. Exaggerated rates of above 10% of market price will be considered as irrational and will not be considered.
- 12. The rate list provided by the bidders to this department must be in clear with signatures and official stamp. Overwritten rates will not be accepted and calculation error reject.
- 13. No pre-qualification or bidding documents will be issued through post, telegraph or email on the day of opening.
- 14. Stamp paper (signed and stamped by the bidder and duly notarized by the Oath Commission) of Rs.100/- shall submit by the applicant with application starting that the

applicant / bidder has never been blacklisted by any Government /Semi Government / Autonomous / Private Organization / Department due to poor services or any other reason.

- 15. Only Qualified firms/applicants in pre-qualification will be invited for their bids.
