- A complete set of Bidding documents can be obtained by an interested bidder personally on submission of a written application along with relevant documents (PEC valid registration for CFY, renewal receipt for 2024-25, CNIC and Undertaking on letter head that the firm is not blacklist in any government /semi government department) from the office of the **Executive Engineer W&P CED GHE/KMG** on cash payment (Non-Refundable) as shown above on any working day during office hours. Bidding documents shall not be issued after 20<sup>th</sup> May 2025.
- The technical bid must be accompanied by a bid security in shape of CDR (5% of the estimated cost) mentioning the name of contractor/firms stated above from scheduled bank of Pakistan.
- In case of rates quoted below or equal to 10% of T/S cost shall be required to provide along with (Financial Bid) an additional performance guarantee in shape of CDR issued by schedule bank of 100% of differential amount (between estimated cost & Bid cost) in favour of **Executive Engineer W&P CED GHE/KMG** and must be delivered to **the Superintending Engineer W&P Baltistan Circle** on the date/time stated above and bids will be opened on date/time stated above in the presence of bidders who choose to attend at the same address.
- The bidding document will be issued to firm/contractor subject to production of bid security in shape of CDR issued by any schedule bank in Pakistan, original CNIC, renewal receipt for CFY and original PEC license.
- In case of Gazette holiday/local holiday, tender shall be opened on next working day without further intimation.
- Terms & conditions and qualification criteria are available in bidding documents.
- All bidders must fill in check list before submission of bid in their own interest as per instructions to bidders which is a mandatory requirement.
- Gilgit-Baltistan Water and Power Department authorities reserves the right to reject any or all the proposals as per GB PPRA and PEC Rules.
