

TERM AND CONDITIONS:

1. A complete set of bidding documents containing detailed terms and conditions may be purchased by interested eligible bidder/authorized representative on submission of written application on original letter head accompanied by the following documents mandatorily.
 - PEC valid registration certificate for CFY(2025-26)
 - CNIC of the prospective bidder/firm.
 - Bid security as specified in shape of CDR only (pay order not accepted) for any scheduled bank in favor of Executive Engineer LG&RD Skardu.
 - Registration/Renewal fee slip of financial year 2025-26 with LG&RD Department.
2. Tender form will not be issued to the contractors having sick or slow moving projects.
3. The procuring agency may reject all bids or any one at any time prior to the acceptance bid or proposals under the provision of GB PPRA rules 2022.
4. Rates quoted below 15% of T/S amount, the bidder shall have to submit and additional 100% of difference amount between TS and rate quoted as performance guarantee in shape of CDR along the bidding documents otherwise the bid shall be rejected.
5. Contractors/firm rates quoted below 100% in any sub-heads or in any items bid shall be rejected.
6. The bidders quoted rates below 25% from TS shall liable to be rejected.

7. Incomplete and lump sum bid shall be rejected.
8. Power of attorney should be on Rs.100 stamp paper in original mentioning the project name and name of representative by attestation of 2nd class magistrate is monetarily.
