**TERMS & CONDITIONS: -**

1. The tender rates would be considered/valid till **30-06-2025**.
2. Tender process will be completed single stage two envelope basis for each component.
3. The rate of each item should be quoted on the basis of F.O.R H. Q basis (**District Astore.**) and for Serial No **1** Rates will be Quoted including 03 days Haltage for quarantine will be responsibility of contractor.
4. Bidder will provide their **Relevant Experience Certificate, Form-C, Registration and original bank statement** (not below than 1 million) of last one Year (April, 2024 to March, 2025).
5. **The Quotations must be filled in computerized, hand writing rates would not be accepted.**
6. Incomplete bids where details with complete specifications etc if not mentioned will be rejected.
7. Delivery time will be maximum 04 weeks from the date of issue of supply order. In case of failure to complete the supplies within stipulated time, total earnest money will be confiscated in favor of the state & supplier will be black listed.
8. Rate will be decided for individual **items bid basis**
9. **3%** of the bid value in the form of call deposit issued by a Schedule bank may be presented in favour of **Deputy Director Livestock & Dairy Development Astore** otherwise bids are liable to be rejected technically.
10. Supply order will be subject to release of funds & according to the budgetary position.
11. **10%** performance guarantee will be taken in advance from successful bidders in shape of cheque in the name of Deputy Director Livestock & Dairy Development Astore.
12. No bidder shall be allowed to alter or modify his bid after the bids have been opened. However, the procuring agency may seek & accept clarification to the bid that do not change the substance of the bid.
13. Supplier will provide Venereal Diseases free certificate (i.e Brucellosis, Vibriosis, Trichomonas's for Dairy animal at the time of delivery of animals. Animal should be vaccinated against Lumpy Skin Disease & Foot & Mouth Disease.
14. For Serial No 01 after acceptance of the bid, a separate agreement deed on registered stamp paper has to be undertaken between the successful tenderers/Suppliers & Department of Livestock Dairy Development Astore.
15. Income tax would be recovered from the suppliers as per Govt. Rules.
16. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the ground for its rejection of all bids or proposals, but it is not required to justify those.
17. The Company/Firms will have to submit original affidavit for not have been blacklisted
18. For any item which is not included in bidding list, the contractor will be bound to provide the item on market prices.
