Terms and Conditions:-

- 1. The firm/ Service Provider must be registered with Income Tax and Sales Tax Departments (where applicable), SECP/ PSEB/ PEC/ Form-C (renewed for 2024-25)
- 2. Sealed bids are to be submitted to the undersigned before the closing date/ time (as mentioned above) which will be opened by the committee in the presence of bidders or their authorized representatives at office of the Chairman, Chief Minister Inspection Team (CMIT), Gilgit-Baltistan near DHO office Gilgit.
- 3. Single stage two envelop as per clause 39(b) of GB PPRA Rules containing Technical and Financial proposals must be submitted before the closing date/ time and those bidders will be qualified for financial bidding who fulfill technical terms and conditions (as per evaluation criteria).
- 4. Rates quoted would be considered only if the same are in Pak rupee and inclusive of all taxes/ duties. The bidder shall submit bid security @ 2% of quoted amount with their Technical Proposal in the shape of Pay Order/ Bank Draft of any scheduled bank in favor of Chairman, Chief Minister's Inspection Team (CMIT), Gilgit-Baltistan, Gilgit. Bids without earnest money will be rejected straightaway.
- 5. All kind of taxes (where applicable) will be inclusive in the bid price and will be borne by the firms/ contractors.
- 6. The employer reserves right to reject any or all proposals, however reasons for rejections shall be communicated accordingly.
- 7. The rates of items offered by the contractor must be filled computerized i.e. manually filled rates will not be accepted.
- 8. The bids will be evaluated on the basis of the detailed terms and conditions, eligibility and qualifying criteria, evaluation criteria as mentioned in the bidding documents/ RFP.
- The interested firms/ Service providers are required to collect the bidding documents/ RFP containing terms and conditions from office of the Chairman, Chief Minister's Inspection Team (CMIT), Gilgit-Baltistan in front of DHO office Gilgit on any working day during office hours on written request on the firms letter head pad on payment of Rs. 6,000 (Six Thousand only) with the Treasury Challan as tender fee, without Treasury Challan no bid document/ RFP will be issued. In case of public holiday due to any reason, the date of receiving and opening of the tender will be on next working day.
