The request for proposals (RFP) is open to all interested well reputed consultants/firms having valid registration with Pakistan Engineering Council upto 30<sup>th</sup> June 2025 in relevant category/code with relevant experience as mentioned in the request for proposals (RFP). Interested firms can purchase RFP documents from the office of the undersigned on submission of written application with payment of Rs. 2,000/- (Non-Refundable) through treasury challan on any working day during office hours upto **02<sup>th</sup> June, 2025**.

3. The consultant(s) providing non-substantiated or incorrect/false information are liable to face legal consequences i.e. disqualification/blacklisting as per GB PPRA Rules. Interested firms must attach the following documents with their proposals: -

- Profile of the organization with head/branch offices, telephone, fax & website alongwith list of personnel staff and certifications.
- Undertaking (in original format) that the firm has not been blacklisted/debarred by any Federal/Provincial /District Government/Semi-Government Departments and no litigation certificate.
- Enlistment the firm with the C&W Department GB.
- All bids may be accompanied by Bid Security amounting to Rs. 400,000/- in shape of deposit of call from any schedule bank of Pakistan in the name of the Executive Engineer C&W Department GB, B&R Division Hunza and must be delivered to the **Superintending Engineer C&W Department Hunza/Nagar at Garelt Hunza** or or before above mentioned date and time in the presence of bidders, representatives who choose to attend, at the same address.

4. The detail eligibility and qualification criteria for selection of consultancy services is given in RFP documents.

5. Proposals (Technical & Financial) should be complete in all respect in sealed envelopes and reach on or before **03.06.2025 upto 12:00 pm**. Technical proposal shall be opened on the same date as mentioned above in presence of the bidders or their representative. Financial proposals of the firms shall be kept in the safe custody un-opened. The financial proposal of the technically qualified firms will be opened in the presence of the firm/authorized representatives. The non-responsive bidders will be communicated for collection of un-opened financial porposals during office hours of undersigned.

6. In case of gazetted holiday/local holiday, tender shall be opened on next working day at same time without further intimation.
