TERMS & CONDITIONS: -

1. The bid security of Engineers cost estimate in form of Call Deposit (Which will be verified from concern bank if deemed necessary) issued by a schedule bank of Pakistan in the name of Executive Engineer B&R Division GB C&WD Astore.
2. Conditional tenders shall not be accepted.
3. In case of firms/ Company/ Joint venture, registered power of attorney and partnership deed in original must be produced for issuance of tender documents. J.V agreement on proper format of PEC, duly signed by all partners of JV, clearly mentioning share of each partner and lead partner duly attested by Magistrate 1st class shall be mandatory.
4. In case of any holiday, tender shall be opened on next working day without further intimation.
5. Rates quoted below 10% from TS cost shall be considered as unworkable however,
 - a). The bidder quoting rate below 10% of TS shall be required to provide along with his bids an additional performance guarantee of 50% of the differential amount (Between TS and Bid cost)
 - b). In case of failure to produce the required differential amount of the bid by the bidder along-with his bid documents, the bid shall be rejected.
6. The revised tender policy issued vide Communication & Works Department Secretariat vide Notification No. Sec-SO-D-9(28)/2022-23/475 dated 13th January, 2023 and PEC bidding document will be followed.
