## **Terms and Conditions:**

- a. The procedure to **Single Stage One Envelope** shall be followed and tender shall be evaluated as per 39 (a) of GB PPRA Rules.
- b. Registration with Pakistan Engineering Council (PEC) in relevant Category duly renewed for the year 2024-2025. (MANDATORY).
- c. Earnest money/Bid Security (02%) in shape of CDR shall be provided with bidding documents from any scheduled bank of Pakistan only. (**MANDATORY**).
- d. Financial Proposals to be quoted in Pak Rupees (RS.).
- e. Authority/power of attorney will not be entertained.
- f. PROPOSAL documents duly sealed and signed by the authorized signatory on every page and enclosed. Tender with incomplete supporting documents shall not be accepted and furnishing incorrect information shall be liable to legal action.
- g. An affidavit on stamp paper of Rs. 100/- must be accompanied with the tender documents to the effect that the bidder has never been blacklisted by any Government/Semi-Government organization/PPRA.
- h. Bidder shall quote firm and final PRICE. *The bid prices should be inclusive of all applicable Government/Local Taxes* and contract shall be executed with the technically qualified lowest evaluated bidder/s on stamp duties (on non-judicial stamp papers) as per PPRA rule.
- i. Conditional tender will not be accepted. No tender will be sold on the date of opening of tender.
- j. The department reserves right to accept or reject tender according to GBPPRA Rule-36.
- k. Tender documents containing detail of evaluation criteria, items, work and specification may be obtained from the office of the undersigned during office hours.
- 1. The firm/contractor winning the bid shall be bound to supply the items to this department within stipulated time of supply order.
- m. In Case of Gazette holiday/ Local Holiday/ Surprise engagement tender shall be opened on next working day without further intimation.
- n. Sealed tender documents must reach at office of the undersigned on or before the dates and time mentioned above. Tender documents will be opened on the same day as schedule given above in presence of contractor or authorized representative.
