- No Sick/ Litigation Certificate and No Black listing certificate duly issues by Water & Power Secretariat and Affidavit of no delayed project in hand duly issued by 1st Class Magistrate. **(MANDATORY)**.
- Earnest money (05%) shall be provided with bidding documents. **(MANDATORY)**.
- If the bidder quoting rates below 10% of Engineer's estimated cost shall be required to provide along with his bid an additional performance guarantee of 50% of the differential amount (between estimated cost & bid cost) in the shape of CDR from any schedule bank of Pakistan. **(MANDATORY)**
- Conditional tender will not be accepted.
- No tender will be sold on the date of opening of tender.
