Terms & Conditions

1. **Contract Period:** Strictly on need basis and subject to the Chinese Engineers' visit schedule.
2. **Usage Basis:** The vehicle will be hired only for the number of days required in a given month. No payment will be made for days the vehicle is not utilized.
3. **Daily Rental:** Quotations must clearly mention the daily rental rate (inclusive of all costs) and must remain valid for the entire contract period.
4. **Vehicle Specifications:** The vehicle must be factory-manufactured bulletproof (B-6 level), fully air-conditioned, in excellent mechanical condition, and compliant with safety standards.
5. **Driver & Fuel:** The vehicle shall be provided with a professional driver and fuel, available in Skardu on short notice. The contractor shall bear all expenses for driver's salary, fuel, tolls, taxes, and complete maintenance.
6. **Reliability:** Failure to provide the vehicle on any scheduled day will result in a penalty of Rs. 45,000/- per day, and repeated failure may lead to contract termination at the contractor's risk and cost.
7. **Bid Security:** A refundable bid security of 2% of the total quoted amount must be submitted in the form of a CDR/Bank Draft issued by a scheduled bank in favor of Project Director, 26 MW Shagarthang HPP, Skardu.
8. **Procurement Method:** Single Stage – One Envelope Procedure as per GBPPRA Rules 2022.
9. **Tender Documents:** Complete specifications and detailed terms can be obtained from the office of the undersigned during office hours up to one day before bid opening.
10. **Right of Rejection:** The Procuring Agency reserves the right to accept or reject any or all bids prior to acceptance in accordance with PPRA Rules 2004 / GBPPRA Rules 2022.
