1.INTRODUCTION.

Assistant Director Livestock & Dairy Development, Ghanche (hereinafter referred to as "the Purchaser") invites/request sealed proposals (hereinafter to as "the Bids") accordingly. Contractors/bidders applying for bids should submit two separates bids/envelopes: one each for financial proposal and Technical, respectively.

GB PPRA RULES TO FOLLOWED

GB PPRA Rules will be strictly followed.

1.1 MODEL OF ADVERTISEMENT.

As per GB PPRA Rule, this tender is being placed online at GB PPRA's websites, as well as being advertised in print media. All respective bidders must collect the bidding documents from the office of Assistant Director Livestock and Dairy Development Ghanche.

1.2 TYPES OF COMPETITIVE BIDDING.

As per PPRA Rule, single stage-Two Envelope Procedure shall be followed as describe below;-

- The bid shall comprise of a single package containing two separate envelops. Each envelop shall contain separately the *Financial proposal* and the *Technical proposal*:
- 2. The envelopes should be marked as "Financial Proposal" & "Technical Proposal" in bold & legible letters to avoid confusion:
- Initially only the envelope marked "Technical Proposal" shall be opened.
- 4. The envelope marked as "Financial Proposal" shall be retained in the custody of the procuring agency without being opened:
- 5. The procuring agency shall evaluate the technical proposal in a manner prescribe in the Section Evaluation of this documents, without reference to the price and reject any proposal which does not conform to specified requirement:
- 6. During the **Technical Evaluation** no amendments in the technical proposal shall be permitted;
- 7. The *Financial proposal* of bids shall be opened publicly at a time, date and venue announced and communicated to the bidders in advance:
- 8. After the evaluation and approval of the technical proposal the procuring agency, shall at a time within the bid validity period publicly open the financial proposals of the technically accepted bid only. The financial proposal of bids found technically non-responsive shall be returned un-opened to the respective bidders:

1.4 BIDDING DETAILS:

All bids must:

- Be accompanied by a call deposit (CDR) of 3% (Schedule bank) against bid value in favor of "Assistant Director Livestock & Dairy Development Ghanche" as earnest money, refundable after successful completion of tender validity period.
- II. Be delivered to the Assistant Director Livestock & Dairy Development, Ghanche at or before 11:00: am on 06-12-2024
- III. The Tenders will be opened on the same date starting at 11:30 am on 06-12-2024 in the office the Assistant Director Livestock & Dairy Development, Ghanche. Initially Technical bid will be opened in the presence of the Contractors or their representatives who care to be present.

1.5 INSTRUCTION TO BIDDER:

TERMS & CONDITIONS:-

- 1. The tender rates would be considered /valid up to 30-06-2025.
- 2. Tender process will be completed in single stage two envelope basis for each component.
- 3. The rate of each item should be quoted on the basis of District Ghanche H.Q basis
- 4. Bidder will provide their Relevant Experience Certificate, Form-C, Registration and original bank statement of last one Year.
- The Quotations must be filled in computerized, hand writing rates would not be accepted.
- 6. Incomplete bids where details with complete specifications etc if not mentioned will be rejected.
- 7. Delivery time will be maximum 03 weeks from the date of issue of supply order. In case of failure to complete the supplies within stipulated time, total earnest money will be confiscated in favor of the state & supplier will be black listed.
 (Contractors/Firms will provide original affidavit paper duly attested to ensure supply within 04 weeks period)
- 8. Rate will be decided for individual items bid basis
- 9. 3% of the bid value in the form of call deposit issued by a Schedule bank may be deposited in favour of Assistant Director Livestock Dairy Development Ghanche otherwise bids are liable to be rejected technically.
- 10. 10% performance guarantee will be taken in advance from successful bidders in shape of cheque in the name of Assistant Director Livestock Dairy Development

- 9. 3% of the bid value in the form of call deposit issued by a Schedule bank may be deposited in favour of Assistant Director Livestock Dairy Development Ghanche otherwise bids are liable to be rejected technically.
- 10. 10% performance guarantee will be taken in advance from successful bidders in shape of cheque in the name of Assistant Director Livestock Dairy Development Ghanche Supply order will be subject to release of funds & according to the budgetary position.
- 11. After acceptance of the bid, a separate agreement deed on registered stamp paper has to be undertaken between the successful tenderers/Suppliers & Department of Livestock Dairy Development GB.
- 12. Income tax would be recovered from the suppliers as per Govt. Rules.
- 13. The Chairman of tender committee reserves the right to accept or reject in part or whole of tender without assigning any reason.
