INVITATION TO BID

The General Administration Department (GAD), Government of Gilgit-Baltistan invites bids from well reputed Firms/Contractors for supply of various equipment's under a project titled ***"Installation/Replacement of IT Equipment for Up-gradation of Sound System in Chief Minister Conference Hall Gilgit and CM Camp Office at Islamabad"***.

2. Tender documents containing terms and conditions, details of items and specifications can be obtained from the office of the undersigned on payment of Rs. 4000/- during office hours before date and time of closing.

GENERAL TERMS AND CONDITIONS:

- i. Earnest money @ Rs. 500,000/- must be attached with the bid in shape of demand draft/pay order in the name of **Deputy Secretary (GAD)**, Gilgit-Baltistan, Gilgit.
- ii. Bids must reach to the office of the undersigned on **8th April, 2025 at 12:00 PM**. Bids will be opened on the same day in the office of **Deputy Secretary (GAD)** at **12:30 PM** in presence of Contractors or their authorized representatives.
- iii. Incomplete bids and without supporting documents shall not be entertained, and furnishing false information shall be liable to legal action.
- iv. An affidavit on stamp paper of **Rs. 100/-** must be attached (original prepared after the date of publication of this notice) with the bid to the effect that the bidder has never been blacklisted by any Government/Semi-Government Organization/PPRA.
- v. The Firm/Contractor shall be bound to supply/install the items on quoted rates in the Chief Minister Conference Hall, Gilgit.
- vi. Firm having their own shop/outlet only can apply, for which document having valid registration of shop/outlet address must be attached.
- vii. The procedure of single stage two envelope shall be followed, and tender shall be evaluated as per weightage/ratio of **70:30 formula "70 for technical proposal and 30 for financial proposal"**. Firm/contractor needs to submit separate proposals for Technical & Financial clearly indicating the name of Firm/Contractor. Documents provided in a single envelope shall not be considered and shall be rejected.
- viii. Firm/Contractor must have completed minimum **five (05) jobs of similar/same nature** and supply order/experience certificate/proof of experience must be attached with tender documents. Supply order in relevant field for whole financial year shall also be considered.
- ix. The department reserves the right to accept or reject any or all bids according to GB-PPRA Rule-36(1).
