Tender Notice for Transportation of Goods

The Controller of the Board of Elementary Examination, Gilgit-Baltistan, invites sealed tenders from reputable and experienced Transport/Service Delivery Companies for the secure and timely transportation of examination materials from the Board of Elementary Examination(BEEGB) Office, NATCO Colony Gilgit, to various examination centers across Gilgit-Baltistan and after the completion of the examinations process, transportation of the same exam material from various exam centres to their respective assessment centers in the same method.


The interested Transporters/ Service Delivery companies must submit the required sealed tender documents on or before **April 4, 2025, by 11:00 AM**, and tenders will be opened on the same day at **11:30 AM** in the presence of bidders or their representatives at the Office of the Controller Board of Elementary Examination Gilgit-Baltistan NATCO Colony Gilgit.

Terms and Conditions:-

1. All tenders must be **computer-typed**; handwritten tenders will not be accepted.
2. Tender documents along-with plan/ procedure/ schedule of dissemination/collection of the exam material can be obtained during office hours from the office of the **Controller, Board of Elementary Examination, Gilgit-Baltistan, NATCO Colony, Jutial, Gilgit.**
3. Technical and financial bids must be submitted separately in sealed envelopes under a **single-stage, two-envelope** bidding process.
4. Any contractor who is blacklisted or has a history of poor performance will be disqualified.
5. Bidders must submit a **5% earnest money deposit** (call deposit) in favor of the **Controller, Board of Elementary Examination, Gilgit-Baltistan.**
6. The service provider must ensure **strict security and confidentiality** of examination materials. Any unauthorized access or breach of confidentiality will result in **legal action and full liability for damages.**
7. The transport/service provider will be fully responsible for any **loss, theft, or damage** to examination materials during transportation.
8. The service provider must ensure **safe, timely, and reliable** delivery of examination materials to examination centers and after completion of exam to their respective assessment centres as per schedule given by BEEGB.

9. Any delays in the examination process due to the service provider's negligence may lead to contract cancellation and financial penalties equivalent to the overall expenditure of the examination.
10. Tender process will be completed in accordance to the GBPPA^R, rules.
11. The Board reserves the right to **immediately terminate** the contract if the service provider violates any condition, fails to perform, or breaches security protocols.
12. The tender committee reserves the right to **reject any or all tenders** on any administrative ground/reason.
13. Late or ambiguous tenders will **not be accepted**.
14. In case of any dispute, the **committee's decision will be final** and cannot be challenged in any court of law.
15. A **non-refundable fee of PKR 4,000** per tender copy must be submitted.
