





Subject:- **CORRIGENDUM "REVALIDATION OF CONSULTANCY SERVICES FOR CONSTRUCTION OF RESIDENTIAL BUILDINGS OF HON'BLE JUDGES OF CHIEF COURT (CONSTRUCTION OF GILGIT-BALTISTAN CHIEF COURT/HIGH COURT BUILDING)".**

1. Communication & Works Department Building Division Gilgit intends to hire services of consultancy firms for **Revalidation of Consultancy Services for Construction of Residential Buildings of Hon'ble Judges of Chief Court (Construction of Gilgit-Baltistan Chief Court/High Court Building)** for which this invitation for consultancy service is issued as per Public Procurement Regulatory Authority Pakistan Rules.
2. Communication & Works Department Building Division Gilgit intends to hire consultancy services from the consultant firms / JVs, who are registered with Pakistan Engineering Council (PEC) and Pakistan Council of Architects and Town Planners (PCATP) and renewed for the year 2024-25.
3. Consultants willing to provide consultancy service for the project will be evaluated on Quality and Cost Based Selection (QCBS) basis of Public Procurement Authority, Pakistan Rules.
4. Consultants firms may obtain detailed bidding documents (Evaluation criteria and TORs) from the office of **Executive Engineer Building Division C&WD Gilgit** upon payment of Rs.5000/- (non-refundable) **read 14 April, 2025 Instead of 17th April, 2025.**
5. A Pre-Bid meeting has been scheduled to be held on 8th April, 2025 at Circle office C&WD GB Gilgit.
6. The request must clearly state **"Revalidation of Consultancy Services for Construction of Residential Buildings of Hon'ble Judges of Chief Court (Construction of Gilgit-Baltistan Chief Court/High Court Building)"**
7. Applications along with two sets of **"Technical Proposal"** and **"Financial Proposal"** separately sealed, signed & stamped on the prescribed forms given in the bidding documents for invitation for consultancy service must be delivered in sealed envelopes by hand or through registered mail, to the office of **Executive Engineer Building Division C&WD Gilgit**, not later than 14 April, 2025 at 11:30 AM. Bids will be opened on same day and venue at 12:00 PM.
