The Grievance Redressal Committee (GRC) was assembled under the chairmanship of Director Water Management Department GB in his office on 13th may. Detail deliberations were made regarding the complaints of the following aggrieved bidder against Technical Bid evaluation process for above work.

- Notice issued for inviting Technical Proposals from Interested Firms through wide publicity in Newspaper & PPRA vide their Notice No. DoWM&I-DEV-ADP (477)-2023-24
- ➤ In response of that advertisement 14 Nos Firms submitted their technical and financial proposals to participate in the bidding process and the procurement committee were opened the technical bids in presence of the bidders and 6 bidders are disqualified in mandatory conditions and remaining bidders are qualified for further evaluation.
- ➤ The Technical Bid evaluation report prepared and signed by the procurement committee, approved by Deputy Director Water Management District Skardu as Chairman procurement committee and subsequently uploaded in PPRA web site vide PPRA Ref No. TSE-20250325832 TSE-20250415914.

Out of 14 bidders, 04 Nos aggrieved bidder Namely "M/S EDEGE POWWER ENGINEERINF, HAJI HASSAN & SONS, MARRY CORPORATION AND YOUSAF ALI& BROTHERS JV UNIVERSAL BUILDERS" have approached/filed complaint to the PAO against the Technical Bid evaluation report. The competent authority constituted GRC vide above referred notification.

PROCEEDINGS:

On the basis of the applicant's reservations, the GRC has thoroughly examined the technical bid documents of the all 04 aggrieved bidder names mentioned above and observed the following facts and findings:

FACTS & FINDINGS:

As per General experience category and Equipment Capabilities given under the qualification criteria of NIT, every firm was to obtain overall 60% and marks in each category is 55% but as per actual re-evaluation by the GRC based on the received bid documents of each bidder, no any above mention firm has obtained the passing marks in general experience category and equipment capabilities. Therefore, the decision of tender evaluation committee seems correct for disqualifying the firms namely "M/S EDEGE POWWER ENGINEERINF, HAJI HASSAN & SONS, MARRY CORPORATION AND YOUSAF ALI& BROTHERS JV UNIVERSAL BUILDERS" for not obtaining the passing marks up to 60% in general experience and 55% in Sub category. The re-evaluation sheet of the technical proposal for pre-qualification of firm is attached.

RECOMMENDATIONS

1. As per re-evaluation of the GRC, the bidders namely "M/S EDEGE POWWER ENGINEERINF, HAJI HASSAN & SONS, MARRY CORPORATION AND YOUSAF ALI& BROTHERS JV UNIVERSAL BUILDERS", are failed to obtained the passing marks 60% in General Experience Category and 55% in sub category under Qualification Criteria of NIT, hence the decision of tender evaluation committee is hereby up held for disqualifying the mentioned firms for further financial bid opening and other necessary proceedings.

The tender opening committee may proceed further/retender as per PPRA rules.
