- NOC of No litigation and No blacklisting renewal upto 30<sup>th</sup> June 2025 from Regional office GB
- Bid security as specified in shape of CDR/TDR from any schedule Bank of Pakistan.
- In case of JV agreement, proper format duly signed by all partners of JV clearly mentioning share of each partner lead and associate partner duly attested by Magistrate 1<sup>st</sup> Class shall be mandatory.
- · Only single bid by one bidder either in form of JV or single bidder.
- Rates quoted below 15% of the technical sanction shall be considered as unworkable, however, the bidder quoting
  rates below 15% of T/S shall be required to provide along with his bids an additional performance guarantee of
  50% of the differential amount (between T/S & Bid) in shape of CDR/Bank Guarantee from any schedule bank.
- In case of failure to produce the required deferential amount of the bid by the bidder along with his bid documents, the bid shall be rejected and security of such bidder shall be forfeited
