2. The bidders shall be screened out in the preliminary checking subject to not fulfillment of all condition, rendered as under: -.

The said application shall be mandatorily accompanied by the following documents.

**MANDATORY CONDITIONS: -**

- 01) PEC valid registration for CFY (2024-25).
- 02) PEC relevant code and category.
- 03) CNIC of the Prospective bidder/firm.
- 04) Enlistment with procuring Agency.
- 05) Affidavit of No Blacklisting from any organization.
- 06) Renewal receipt for CFY (2024-25).
- 07) Signature of bidder/witness on bidding documents is mandatory.
- 08) Late submission of bid will not be entertained.

**TERMS & CONDITIONS: -**

01) The bid security 2% of Engineers cost estimate in form of Call Deposit (Which will be verified from Concern bank if deemed necessary) issued by a schedule bank of Pakistan in the name of Executive Engineer PHE and Building Division Skardu.

02) Conditional Bids shall not be accepted.

03) In case of firms/ Company/ Joint venture, registered power of attorney and partnership deed in Original must be produced for issuance of tender documents. J.V agreement on proper format duly signed by all partners of JV, clearly mentioning share of each partner and lead partner duly attested by Magistrate 1<sup>st</sup> class shall be mandatory.

04) The employer reserves the right to accept or reject any bid and the bidding process and reject all Bids with reason therefor (if any)

05) In case of local holiday, tender shall be opened on next working day without further intimation.

06) Rates quoted below 10% from TS cost shall be Considered as unworkable however,  
a). The bidder quoting rate below 10% of TS shall be required to provide along with his bids an additional performance guarantee of 50% of the differential amount (Between TS and Bid) in Shape of CDR from any



b). In case of failure to produce the required differential amount of the bid by the bidder along-with his bid documents, the bid shall be rejected and security of such bidder shall be forfeited.


07) The bidders can submit application within due date and time during office hours. After that, no application will be entertained. The application will then be scrutinized by the Divisional Procurement Committee and then bidding documents will be issued. The Bid documents will be issued on production of original 2% earnest money (CDR) (Which will be verified from concern bank) with its copy attach and treasury receipt challan with cost of tender form as mentioned against each work which can be received from the office of the Executive Engineer PHE and Building Division Skardu near Parishan Chowk during office hours.

08) Overwriting on bidding document is not allowed and in case of any overwriting/omission is found the Bid shall be rejected.

09) Provision of false or misleading information by any bidder may result in immediate disqualification at Any stage of the procurement process.

10) Performance guarantee shall be @ 10% of the contract amount from any scheduled bank/ insurance Company having AA rating.

11) Bids shall be opened in the office of the Executive Engineer at PHE and Building Division Skardu near Parishan Chowk in the presence of the committee members on above mentioned date and time.
