- The bidder quoting seriously unbalanced rates from the engineer's cost estimates and PC-1 provision will be dealt as per provisions of PEC bidding documents and amendments issued by the competent authority from time to time.

The additional performance security (differential amount) (between T/S & Bid) cost shall have to submit in shape of CDR from any schedule bank of Pakistan and the Guarantee bond of any Insurance Company shall not be entertained as per notification vide Communication & Works Secretariat No. Sec-SO-D-9(28)2024-25/2001 dated 29<sup>th</sup> May, 2025.
