MANDATORY CONDITIONS:

The bidder shall be screened out in the preliminary checking subject to fulfillment of all conditions, rendered as under:

The said application shall be mandatorily accompanied by the following documents.

1. PEC valid registration for CFY 2024-25.
2. PEC relevant Category and Code.
3. Attested CNIC of the prospective bidder.
4. Enlistment with Procuring Agency.
5. Certificate of No Sick Scheme & No Litigation from respective Chief Engineer Office of concern region.
6. Attested copy of receipt of renewal fee for 2024-25.
7. Signature of bidder / witness on bidding documents is mandatory otherwise the bid will be straightaway rejected.
8. Late submission of bid will not be entertained.

TERMS & CONDITIONS:

1. The bid security **2%** of Engineers cost estimate in the form of Call Deposit issued by a scheduled bank of Pakistan in the name of XEN PHE & Building Division Skardu valid for a period of 28 days beyond the bid validity period. Only CDR will be accepted. Pay order and Bankers' cheque will not be accepted.
2. Conditional tenders shall not be accepted.
3. The bidding documents will be issued either to the original bidder or to the authorized representative with power of attorney in original. In case of firms / Company /Joint venture, registered power of attorney and partnership deed in original must be produced for issuance of tender documents J.V agreement on proper format duly signed by all partners of J.V clearly mentioning share of each partner and lead partner duly attested by Magistrate 1st Class shall be mandatory.
4. The employer reserves the right to accept or reject any bid and the bidding process and reject all bids with reasons thereof (if any).
5. In case of holiday, tender shall be opened on next working day without further intimation.

6. Rates quoted below 10% from TS Cost shall be considered as unworkable however,
- The bidder quoting rate below 10% of TS shall be required to provide along with his bids an additional performance guarantee of 50% of the differential amount (Between TS and Bid) in shape of CDR or Bank guarantee only from any scheduled bank of Pakistan. Bond from Insurance Company shall not be accepted.
 - In Case of failure to produce the required differential amount of the bid by the bidder along with his bid documents, the bid shall be rejected and security of such bidder shall be forfeited.
7. The bidders can submit application up to (16th Dec, 2024) during office hours. After that, no application will be entertained. The application will then be scrutinized by the Divisional Procurement Committee. The bid documents will be issued on production of original 2% earnest money (CDR only) with its copy and treasury receipt challan attached with cost of tender form as mentioned against each work which can be received from the office of the Executive Engineer PHE & Building Division GB C&W Skardu during office hours on 19th Dec, 2024 and onwards.
8. Bids shall be opened in the office of the Executive Engineer PHE & Building Division on above mentioned dates and time.
9. Contractor / Bidders are advised to quote the rates on Blank spaces of each and every sub head. Items wise rates will not be accepted except the MR items.
