The Technical Evaluation Committee observed that the bidder (M/s **GBEETECHIVE**) has not furnished the mandatory technical details, including make, model, and compliance documentation, for the offered servers and allied hardware equipment as required under the bidding document. As per the evaluation criteria,

submission of complete technical documentation was mandatory. Accordingly, the bid is declared technically non-responsive and is not considered for further evaluation.

In addition, the bidder (M/s GBEETECHIVE) has also failed to submit documentary evidence of relevant experience in the establishment of datacenter and the supply of servers and allied hardware equipment as required under the bidding document. The absence of verifiable experience certificates/work orders demonstrating similar nature and scale of assignments renders the bid non-compliant with the mandatory eligibility and technical qualification criteria. Accordingly, the bid is declared technically non-responsive and is not considered for further evaluation.

Based on the evaluation of mandatory requirements, M/s Aidco JV YS Enterprises and M/s Soft Technical Group were found responsive, and accordingly recommended for technical evaluation.





During the mandatory responsiveness check, **M/s GBEETECHIVE** was declared non-responsive. However, the bids submitted by **M/s Aidco JV YS Enterprises** and **M/s Soft Technical Group** met all initial mandatory requirements and were therefore considered for detailed technical evaluation (**Annex-G**). The Committee then conducted a comprehensive technical assessment of these bidders against the criteria outlined in the bidding documents, assigning marks based on the documentary evidence provided. As per the bidding documents, a minimum of 70% marks was required to qualify technically. Following the detailed evaluation, both bidders were found technically qualified and responsive. **M/s Aidco JV YS Enterprises** secured 87.5 marks, while **M/s Soft Technical Group** secured 94.5 marks in the technical evaluation.
