- 1. The Bidder must be registered with the Pakistan Engineering Council under the appropriate category with the specialized code ME-07 (ix) for the year 2024-25. (Mandatory)
- 2. The Bidder must be enlisted and duly renewed with Water & Power Department GB for CFY. (Mandatory)
- 3. Authorization certificate from the Original Equipment Manufacturer (OEM) must be produced. (Mandatory)
- 4. The manufacturer must possess a minimum of ten (10) years of documented experience specifically in the production of TG sets, with expertise in turbine runners. To demonstrate proven experience the bidder must provide evidence (such as project certificates, client testimonials, or factory audit reports). (mandatory)
- 5. The bidder must have successfully executed at least one (01) similar project i.e the supply of TG sets with a minimum capacity of 3 MW during the last five (05) years. Completion certificates issued by the respective regional offices must be submitted as documentary evidence. (Mandatory)
- 6. The bidder must provide a bank credit line certificate for a minimum of PKR 50 million as evidence of financial stability. (Mandatory)
- 7. The bidder must provide bank statements showing a minimum transaction of PKR 50 million over the last six (06) months as evidence of financial stability. **(Mandatory)**
- 8. No backlist, no default and no litigation certificate from the notary public must be attached. (Mandatory)
- 9. Bidding documents will only be issued to those bidders who have fulfilled all the above conditions.
