The Meeting was convened under the Chairmanship of Prof. Muhammad Bilal, Additional Director Higher Education(Colleges), & P&D, Directorate of Higher Education, GB in pursuance of Notification No.Sec-HTS-Edu-1-2(5)/2025-26(Dev)/4824 dated 19<sup>th</sup> December, 2025(Annex-A)

The purpose of the meeting was to review and decide upon the appeal submitted by M/S, ABID HUSSAIN, Govt. Contractor and General Order Suppliers regarding his disqualification during the technical evaluation for procurement of Supply of Spare Parts and work order for sub head A13001 Repair of Transport under regular budget 2025-26.

**REVIEW OF APPEAL AND GRC DECISION**

**1. M/S ABID HUSSAIN, Govt. Contractor and General Order Suppliers**

**Claim.**

1. The Firm contended that it had submitted all the documents required for bidding.
2. The Firms is the lowest bidder.
3. The other bidders participated in the bidding don't fulfill the requirements.
4. Firm's bid has been rejected due to no existence of shop/workshop in Chilas, Diamer inspite of provision of undertaking for doing the repair and maintenance work of the college transport.(Annex-B)

**GRC Findings**

Upon detailed examination of bidding documents:

1. An amount of Rs.38,20,000/- (Rupees Thirty-Eight Lac Twenty thousand only) has been appropriated in regular budget of Govt. Boys Degree College Chilas, Diamer for the financial year 2025-26 against the sub head A13001-Repair of Transport
2. Basic bidding document prepared at Govt. Boys Degree College Chilas, Diamer, and the bidding documents submitted by the aforementioned firm, the Grievance Redressal Committee noted the following:
  1. Non-Compliance of GB PPRA 2022 Rules 23, 24 & 39 in Bid Document Preparation by Procuring Agency(Govt. Boys Degree College Chilas, Diamer,)
  2. Violated Rules  
Rule 23: Open Competitive Bidding (OCB) procedure not followed.  
Rule 24: Limited Competitive Bidding procedure not followed.

Rule 39: Evaluation criteria and other mandatory requirements not defined.

**Decision and Recommendations of GRC:**

**In view of the above, the Grievance Redressal Committee unanimously concluded that:**

1. The procuring agency's failure to prepare a bid document in compliance with GB PPRA 2022 Rules 23, 24, and 39 undermines transparency, fairness, and accountability in the procurement process.
2. The tender may be treated/considered as ab initio/cancelled. Therefore, it is mandatory that the agency re-prepare the bid document in strict accordance with the aforementioned rules to avoid legal and procedural complications.
