- 1. The bidding process will be conducted under the "Single Stage, Single Envelope" method laid down in PPRA Rules. Bidding documents, containing detailed terms & conditions, method and procedure for submission of bids, bid security, bid validity, guarantee, etc. are available for the interested bidders at *GBRSP Head Office*, *Noor Colony, street No. 02*, *Jutial, Gilgit*. The price of the bidding documents is Rs. 2000/-(non-refundable) if collected in hard form otherwise the documents can be downloaded for free from www.gbrsp.org.pk
- The bids, prepared following the instructions in the bidding documents, must reach GBRSP Head Office, near Oasis Hotel, Street No. 12, Noor Colony, Jutial, Gilgit on or before 11:00 AM, November 21, 2024. Bids will be opened the same day at 11:30 AM
- 3. Bidders must mention the **Lot Number** for which they are submitting bids. If a bidder wishes to apply for more than one lot, they must submit a **separate bid document** for each lot, along with the applicable **bid document fee** for each.
- 4. GBRSP reserves the right to accept or reject any or all proposals as per PPRA Rules.
- 5. Responsive Bidders are required to submit the following documents with a technical bid (Specification of required equipment) attached as Annexure A:
 - i) Relevant Experience of at least 3 years
 - ii) Registration Certificate (for solar units SECP Registration is mandatory)
 - iii) Affidavit that the firm/company/manufacturer has never been blacklisted.
 - iv) Profile of firm/company/manufacturer.
 - v) List/contact/project details the bidder has undertaken with different organizations.
