3. Contract / suppliers may offer tender in which they have complete setup, own shop, store, work shop with all documentary evidence.
4. The contractor / supplier must adequate supply/ stock in Gilgit and the firm will be bound to supply demanded items and same rates as well.
5. Separate envelope containing technical and financial proposal must be submitted before the closing date and time accordingly.
6. If provided rates are not similar to market rates then this office has the authority to cancel the rates.
7. The rates of the items not listed in the "prescribed form" will be determined in accordance with the prevailing retail price / market rate at the time of supply. The contractor / supplier will not have to right to challenge the market rates collected from the market by the concerned staff of the GBDMA office Gilgit.
