1. The bidder must be registered with the Securities and Exchange Commission of Pakistan (SECP)/Form-C. For bidders registered outside Gilgit-Baltistan, the company must be registered with the Income Tax and Sales Tax Department, and it must be on the Active Taxpayers List (ATL) of the Federal Board of Revenue.
2. Tender documents can be obtained from the office of the Director, Special Education Department, GB Near KIU Main Campus Gilgit, Ph: 05811-960293 from the date of advertisement till the last date mentioned above during office hours on deposit/payment through treasury challan of non-refundable amount as mentioned above against each lot.
3. Bidding will be carried out by adopting GB Public Procurement Rule 2022 clause 39 (b) "Single-stage Two Envelops procedure" and the final selection will be based on the lowest bid among the technically qualified bidders as per the criteria outlined in the bidding documents.
4. Proposals, complete in all respects, in accordance with the instructions provided in the bidding document (properly prepared content page, binding, paging, flagging of all required documents) in sealed envelopes should reach on above mentioned last date and time scheduled against each lot in the office of the Director, Special Education, GB Gilgit, and the Technical Proposals at 1st stage shall be opened in presence of the bidders or their authorized representatives as per above given schedule whereas the original financial proposal of technically qualified bidders(i.e. compliant to technical specifications and other terms and conditions) shall be opened subsequently. Furthermore, only "Typed" financial bid will be considered valid in other words hand written financial bids will not be accepted.
5. Call deposit receipt (CDR) for each lot mentioned above from any schedule bank including KCBL in the name of Director, GB Near KIU Main Campus Gilgit, may be attached with the Technical Bid of the respect Lot. The CDR can be verified / vetted from the concerned banks. In case CDR/Call deposit receipt not found attached with Technical Bid, the Firm/Contractor will be declared as "non-responsive". Successful bidder will have to submit 10% Performance Security of total bid price in shape of CDR or Bank guarantee from any schedule bank including KCBL in the name the Director, Special Education, GB, within 7 days after bid acceptance.
6. A cover letter shall be furnished with Technical Proposal by attaching proformas and Financial Proposal with proforma signed by an official authorized to enter contracts. The cover letter shall introduce the firm and summarize general qualifications, including the firm's legal entity name, address, email address, phone number of contact person, and a short synopsis of the proposal and credentials to deliver the services sought under the bidding document.
7. An affidavit on stamp paper of Rs. 100/- must be accompanied with the bid to the effect that the bidder has not been blacklisted by any government/semi government organization/GB PPRA.
8. The bidder providing unsubstantiated and/or incorrect information is liable to legal action and/or disqualification.
9. The Procuring Agency (Special Education Department GB) reserves the right to increase/decrease the quantity with the reason thereof.
10. The Procuring Agency (Special Education Department, GB) reserves the right to accept/reject any bid or to annulled the whole tender process with assigning the reasons thereof.
11. In case of Local Holiday, the bidding process will be held on next working day on same time and venue.
