- Affidavit No litigation, No Sick Project certificate and no blacklisting.
- Bid security as 5% E/M in shape of CDR from any schedule Bank of Pakistan.
- In case of JV agreement, proper format duly signed by all partners of JV clearly mentioning share of each partner lead and associate partner duly attested by Magistrate 1st Class shall be mandatory.
- The bidder must submit 01 set of bidding documents duly addressed to Executive Engineer B&R Division Chilas and one Duplicate copy addressed to Chief Engineer Diamer-Astore Region for transparency.
- Rates quoted below 10% of the technical sanction shall be considered as unworkable whoever, the bidder quoting rates below 10% of T/S shall be required to provide along with his bids an additional 50% of the differential amount (between T/S & Bid) in shape of CDR Guarantee from any schedule bank. CDR from KCBL shall not be entertained

In case of failure to produce the required deferential amount of the bid in shape of CDR from scheduled Bank of Pakistan by the bidder along with his bid documents, the bid shall be rejected and security of such bidder shall be forfeited
