

Expression of Interest (EOI)

Pre-Qualification of Firms for the period of 03 years for Procurement and Supply of Forest/Ornamental Plants

The Forest, Wildlife & Environment Department, Government of Gilgit-Baltistan is implementing the PSDP-funded project titled ***“Up-Scaling of Green Pakistan Programme – Revival of Forestry Resources in Gilgit-Baltistan”***

2. The Department intends to **pre-qualify firms under rule 19 and 19A of the Gilgit-Baltistan public procurement Regularity Authority (GB PPRA Rules , 2022)** having adequate technical capacity and relevant experience for the **Procurement and Supply of Forest Plants** (Conifers & Broadleaves, Bare Rooted Forest Plants, Potted Forest Plants, Bare Rooted Ornamental Plants, Potted and Ornamental/Large-Sized Plants,) for designated plantation sites across **Gilgit, Diamer, and Baltistan Forest Circles**, and thereafter issue Invitations to Bid and sign framework agreement(s) with the selected bidder(s) following the competitive process.
3. Applications for **Pre-Qualification** are invited from authorized firms/companies having relevant experience, strong technical and financial standing, and fulfilling the eligibility criteria provided in the Pre-Qualification Document.
4. **Eligibility Requirements (Mandatory):**
 - Valid SECP registration/ District Registrar/PEC with minimum of five years firm age , **Federal Seed Certification** issued by the competent authority.
 - Relevant experience of supplying forest plants during the last five **(05) years**, with cumulative supply of **not less than 0.500 million plants**.
 - A minimum of **Rs 50 million** credit transaction during the last three years with closing balance of **Rs 3.00 million** as of closing tender submission time.
 - JV is strictly not allowed.
 - Similar supplies made to Government/Semi-Government/Autonomous Bodies within Gilgit-Baltistan.
5. The **Pre-Qualification Document** may be obtained from the office of the Project Director during office hours upon payment of a non-refundable fee of **PKR 10,000/-**, and can also be viewed on the Department’s website www.fwegb.gov.pk and GB PPRA website www.gbppra.gov.pk.
6. Interested firms/companies fulfilling the prescribed criteria may submit their applications, complete in all respects, to the office of the Project Director **on or before 11:00 AM on December 29, 2025**, along with the requisite documents/information as specified in the Pre-Qualification Document. EOI will be **opened on the same day at 11:30 AM** in the presence of applicants or their authorized representatives who may choose to attend.
