 - Bid security shall provide to department for verification of relevant bank.
 - Bidding documents shall not be issued to constructors who have delayed already awarded projects
 - Bidding documents will not be issued who have blacklisted.
 - Conditional bid shall not be acceptable to the department.
 - Unbalance quoted rates will be dealt as per rule/policy mentioned in bidding documents.
 - The Procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal under the provision of Rule-36 of GB PPRA Rules 2022.
