TERMS & CONDITIONS:

- 1 the bidder must be registered with Pakistan Engineering Council under the appropriate category with the specialized code ME-07 (ix) for the C.F.Y **(Mandatory)**.
- 2 The bidder must be enlisted and duly renewed with Water & Power Department GB for C.F.Y **(Mandatory)**.
- 3 The manufacturer must possess ISO-9001 certification (Renewed). **(Mandatory)**.
- 4 The rating of manufacturer must be Tier-II or above. **(Mandatory)**.
- 5 Authorization certificate from the manufacturer must be produced **(Mandatory)**.
- 6 The manufacturer must possess minimum of ten (10) years of documented experience specifically in the production of TG sets, with expertise in turbine runners. To demonstrate proven experience the bidder must provide evidence (such as project certificates, company website, sale / production Manager contract Numbers (Email, Telephone No.) **(Mandatory)**.
- 7 The bidder must have successfully executed at least two (02) similar projects i.e the supply of TG sets with a minimum capacity of 02 MW unit in Pakistan. Completion certificates issued by the regional offices must be submitted as documentary evidence. **(Mandatory)**.
- 8 The bidder must provide a Bank credit line certificate for a minimum of PKR 50 million as evidence of financial stability **(Mandatory)**.
- 9 The bidder must provide Bank statements showing a minimum transaction of PKR 50 million over the last six(06) months as evidence of financial stability **(Mandatory)**.
- 10 No black list, no default and no litigation certificate from the notary public must be attached **(Mandatory)**.
- 11 Completion period of work will be 06 months after issuance of commencement order **(Mandatory)**.
- 12 The bidder must provide schedule of supplies. **(Mandatory)**
- 13 Bidding documents will only be issued to those bidders who have fulfilled all the above conditions.
- 14 Bidding documents can be purchased from the office of the Executive Engineer W&P Department GBHEW Division, Gilgit during office hours upon cash payment (not refundable) as mentioned above.
- 15 The bid shall be reached to the office of the Superintending Engineer W&P Circle Gilgit on or before the bid opening date, bids will be opened in the presence of the bidder or their authorized representative who choose to attend.
