

Sealed tenders are invited from reputed registered Government firms/dealers/supplier/contractors for procurement of the following category of goods/services **Transport Repair, Diet Feeding to Police Horses** (However the tenders Stationary, Other Miscellaneous,, Repair of Machinery & Equipment's) will be tendered under the GB PPRA S.R.O 1665(1)2023) is required for **Commandant Armed Reserve Police Gilgit-Baltistan, Gilgit** for the **Financial Year 2025-26**. Last date for submission of complete documents/forms etc and bid/tenders will be opened on **01.07.2025** on 8:30 am to 10:30 am.

TERMS & CONDITIONS:-

1. Sealed tenders may be submitted to undersigned before the closing date and time, which will be opened by the committee on above mentioned date and time in presence of the contractors/suppliers or their authorized representatives at Commandant Armed Reserve Police Gilgit-Baltistan, Gilgit.
2. Contractor/Supplier/ has complete set up (own shop, and past experience with documentary evidence in the relevant field).
3. The Contractor/Supplier must be sole proprietor/ Certificate of Chamber of Commerce having his own complete setup (shops) containing adequate supplies in Gilgit Town and he will be bound to supply demanded items at the Commandant Armed Reserve Police Gilgit-Baltistan, Gilgit
4. The Bid Security/call deposit in shape of Bank Draft / Pay Order by a Scheduled bank in the name of "Commandant Armed Reserve Police Gilgit-Baltistan, Gilgit.." (CDR for Transport Repair Rs. 500,000/- Diet Feed Items Rs.500,000/-) may be attached with the bidding/tender documents. Tender without call deposit from a scheduled bank, will not be accepted.
5. The bidding document of only registered firms/dealers/suppliers/contractors shall be entertained.
6. The rates of items if not covered in the "Prescribed Form" will be determined in accordance with the prevalent retail price in the open market at the time of supply.
7. All kind of Taxes applicable (if any) will be inclusive in the bid price and borne by the firms/ dealers/ suppliers/contractors.
8. Conditional, ambiguous & incomplete tenders shall not be accepted.
9. Bank statement for the last 02 years, work Experience in relevant field and Registration Certificate, Vendor Number must be attached with bidding documents duly attested.
10. JV not accepted.
11. The competent authority reserves the right to accept or reject any one or all of the tenders as per relevant instructions/guidelines of GB PPRA rules.
