Prescribed Form/Bidding documents containing terms & conditions and details for category may be obtained from the office of the Inspector General Prisons office near Airport Old District Jail Office Gilgit during office hours by paying Rs,6000/- (Rupees Six Thousand only) Repair of Jail, tender Document fee and by Paying Rs. 4000/- (Rupees Four Thousand only) uniform Article (non-refundable) last date for tender submission is 8<sup>th</sup> September, 2025 at 11:00 AM which will be opened on same date at 11:30 AM in presence of the bidder/ suppliers or their authorized representatives.

## **TERMS & CONDITIONS:-**

- i. The firm will submit earnest money as quoted above with the tender documents in the form of CDR from any scheduled Bank in the name of DDO Inspector General Prison's Gilgit,
- ii. Tender with incomplete supporting documents shall not be accepted, and furnishing of false information shall be liable to legal action.
- iii. Items should require to be delivered/provided & fixed/ repaired and carried out building repair work at various districts after issuance of Supply Order from Inspector General Prisons Department GB, Gilgit
- iv. The bidder should require to be attached one year bank statement near to 50 Lac Transaction with Rs. 10 lac show closing balance.
- v. Un-realistic rates i.e over or under estimated, conditional and incomplete (against any items) shall be rejected straight away.
- vi. An affidavit on stamp paper of Rs. 50/- must be accompanied with the tender documents to the effect that the bidder has never been blacklisted by any Government/Semi-Government organization.(all document must be attested)
- vii. Successful contractor/Firm shall be liable to supply the items in the whole financial year 2025-26 within a quoted rates.
- viii. Contractor must be enlisted to any recognized Govt entity.
  - ix. Tender will be evaluated under per PPRA rule 36(b) single Stage -Two Envelopes)
