

**TERMS & CONDITIONS**

01. Sealed tenders may be submitted to undersigned before the closing date and time, which will be opened by the Committee on above mentioned date and time in presence of the Contractors/Suppliers/Firms or their authorized representatives at the office of the Secretary Food Department Gilgit-Baltistan, New Civil Secretariat Jutial Gilgit.
02. Contractors/Suppliers/Firm may offer tender only if they have complete setup (Own Shop and Work Shop for repair of transport only) with all documentary evidence.
03. The Contractor/Supplier must have adequate supply/stock of spare parts in Gilgit Town.
04. The Tender will be opened in accordance with GB PPRA Rules 2022 under Section 39(a) Single stage one envelope. Bid must be typed. Handwritten bid shall be rejected.
05. Tender must be offered mentioning name in bold letters on sealed envelope.
06. Each bid shall comprise one single envelope containing separately financial proposal and technical proposal.
07. The bid security/call deposit (refundable) in shape of bank draft by a scheduled bank in the name of Secretary Food Gilgit-Baltistan may be attached with the bidding/tender documents. Tender without call deposit shall not be entertained.
08. The Committee will visit the Shop and work shop of bidder and have rights to reject in case of non-existence of bidder's own Shop and Workshop with technical staff.
09. The bids of only registered Firms/Dealers/Suppliers/Contractors will be entertained.
10. The rates of items if not enlisted in the "Prescribed Form" will be determined in accordance with the prevailing retail price/market rate at the time of supply.
11. Conditional, ambiguous and incomplete tender documents shall not be accepted.
12. Bank Statement/transaction for last one year, (Rs. 5,000,000/- for repair of vehicles items & 3,000,000 bank transaction for Stationery Items) Five years' work experience in relevant field, firm registration certificate/Form-C, Non Black Listed Affidavit, CNIC of the owner, Treasury Challan TR-6 issued by DDO of Secretary Food GB duly stamp from Treasury Office/NBP must be attached with technical proposal, Letter Pad of Firm with address, Vendor Number & Telephone Number must be attached with bidding documents.
13. Irrational/artificial and dubious rates offered by the Firms/Contractors shall be rejected.
14. All kind of taxes applicable (if any) will be inclusive in the bid price and borne by the Firms/Dealers/Suppliers/Contractors.
15. The Competent Authority reserves the right to accept or reject any one or all the tenders as per relevant instructions/guidelines of GB PPRA rule 2022.
