- 1. The firm must have a registration original with PEC renewed for the year 2025-26.
- 2. PEC relevant Category and Code.
- 3. Receipt of renewal from Works Department for the year 2025-26 is compulsory for issuance of the tender form.
- 4. Contractors/firms should provide **2% Bid Security** of the estimated cost in shape of **Call Deposit** in the name of Executive Engineer LG&RD District Astore from any schedule bank of Pakistan.
- 5. Submission of Call Deposit/Receipt 2% (Original) is pre-requisite for obtaining tender forms.
- 6. Bidding documents can be obtained from the office of the Executive Engineer LG&RD District Astore by producing original CNIC on 3rd December, 2025 during office hours.
- 7. Conditional/incomplete tenders will be summarily rejected.
- 8. If the quoted bid is **below 15% of the estimated cost**, the bidder shall be required to provide along with his bids an additional performance guarantee of **100% of the differential amount** in shape of CDR from any schedule bank of Pakistan in the name of Executive Engineer LG&RD District Astore.
- 9. The Bids having Bid Price lower than 25% shall be liable to be rejected".
- 10. Tender documents will be issued to the original bidders/contractors or their authorized agents producing power of attorney.
- 11. No bidding documents will be issued to the contractors/firms who have been failed to complete the awarded work earlier by this department, within the stipulated time period without any solid reason.
- 12. In case of gazetted/local holiday the tender will be opened on next working day without any further notice/information.
