**TENDER NOTICE**

Tender in sealed envelopes, for **“Repair of Transport”** as detailed/specified in bidding form/documents, for DDO Secretary Higher, Technical & Special Education office Gilgit for the Financial Year 2025-26 (ending on 30<sup>th</sup> June 2026), are hereby invited from the eligible/registered Govt. Contractors/Firms on the date & time mentioned below which will be opened by Chairman procurement committee/DDO/Deputy Secretary (Budget & Accounts Education) in presence of the contractors or their authorized agents who care to attend, on 03-09-2025 at 11:30 at the office of DDO/Deputy Secretary (Budget & Accounts Education) GB:-

**TERMS & CONDITIONS:-**

1. The tender rates will stand valid only for the budget Head mentioned above for the office of DDO Secretary Higher, Technical & Special Education GB only.
2. The tender/bidding document of only registered firms/dealers/suppliers/contractors shall be entertained. Tenders/bids having incomplete documents shall be rejected under PPRA Rules.
3. The Contractor/Supplier must be sole proprietor having his own complete setup (shop & workshop) containing adequate supplies in Gilgit city.
4. Prices offered should be for each/every item separately (which shall be decided on lot basis); partial offers shall be rejected straightaway. Conditional offers shall also be considered as non-responsive.
5. The Procurement Committee shall physically inspect/check the bidder's Shop/Store/Workshop to satisfy itself that the same exists with adequate supplies along with technical expert/staff.
6. Bid price against each item should not be unrealistically higher or unrealistically lower than the prevailing general market price.
7. Incomplete bids with in-complete details (specifications/strength/manufacturer etc) will be rejected.
8. 5% of the bid value in the form of call deposit, issued by a Schedule bank, may be deposited in favour of DDO Secretary Higher Technical & Special Education GB otherwise bids are liable to be rejected technically.
9. After acceptance of the bid, a separate agreement deed has to be undertaken between the bidder & procuring agency i.e office of DDO Secretary Higher Technical & Special Education, GB.
10. The Chairman of procurement committee reserves the rights to accept or reject in part or whole of tender, under Gilgit-Baltistan PPRA Rules 2022 (as amended from time to time).
11. Bidder will be selected on the basis of the rates offered and his experiences & performance in relevant field i.e shop & workshop in Gilgit city & Technical experience in relevant field.
12. The Company/Firms will have to submit affidavit for not have been blacklisted on legal stamp paper.
13. Tender process will be completed in accordance with the relevant Rules Gilgit-Baltistan PPRA 2022.
14. Bidding Form/documents can be obtained from the office of the DDO Secretary Higher Technical & Special Education Gilgit w.e.f 2<sup>nd</sup> September, 2025 free of cost.
