TERM AND CONDITIONS:

- A complete set of bidding documents containing detailed terms and conditions may be purchased by interested eligible bidder/authorized representative having power of attorney on stamp paper dully verified on submission of a written application on original letter head accompanied by the following documents mandatorily.
 - PEC valid registration certificate for 2024-25
 - CNIC of the prospective bidders
 - Bid security as specified in shape of CDR for any scheduled bank in favor of Executive Engineer LG&RD Skardu.

- Enlistment with LG&RD Department for the financial year 2024-25 is mandatory.
- 2. Contractors having sick or slow progress projects will not be eligible to participate.
- 3. In case of firm/company/JV, registered power of attorney and partnership deed in original duly attested by the magistrate must be produced for issuance of tender documents. In case of Joint Venture, the approval of most advantageous bid is subjected to the provision of joint account & valid IBAN Number of the JV account.
- 4. The procuring agency may reject all bids or any one at any time prior to the acceptance of proposals under the provision of G.B PPRA rules.
- 5. The bid should be valid for 90 Days.
- 6. Tender documents shall only be issued to the bidders or their authorized representatives on production of his/her Original CNIC having valid power of attorney in original. The employer reserves the right to verify the power of attorney before the issuance of tender documents.
- 7. Rates quoted below 10% of T/S amount, the bidder shall have to deposit additional 100% of difference amount between TS and quoted rate as performance guarantee in shape of CDR along the bidding documents otherwise the bid shall be rejected.
- 8. Conditional /incomplete and lump sum bid shall be rejected.
- 9. Power of attorney for bidding should be on Rs.100 stamp paper in original mentioning the project name and name of representative by attestation of 2nd class magistrate is mandatory.
