1. The Gilgit Development Authority (GDA) represented by Project Director, Project

Management Unit (PMU) "Employer") has received funds from the Federal Govt, through PSDP towards
the project construction of sanitary and sewerage system Gilgit city and it is intended that part of the
proceeds of the funds will be applied to eligible payments under the Contract for the "Disposal of
Surplus excavated Material" from roads/streets surfaces under project packages I,II (From RCC Bridge
Baseen to Bab-e-Gilgit) &III (from Tablighi Markaz to Nagar Colony Konodas).

2. Bidding (Single stage One envelop bidding procedure) is open to all eligible Bidders meeting the following mandatory conditions as given in bid documents:-

- 5. Bidding documents will be issued only to contractor(s) /firms or their authorized representatives who will show original PEC License and power of attorney alongwith original authority letter for the mentioned works.
- 6. Conditional, incomplete and bids filled with lead pencils will not be entertained.
- 7. All bids must be accompanied by a Bid Security in the amount of Rs. Rs.1,000,000/- (Rupees Ten



Lacs only) in shape of CDR/ Pay Order from a scheduled bank of Pakistan, and must be delivered to Office of The Project Director, Project Mangement Unit Sanitary and Sewerage System Gilgit City near Ali Sadpara Chowk Naveed Shaheed Road Zulfiqarabad Jutial Gilgit at or before 11:00 am hours, on 03-12-2024 (Tuesday). Bids will be opened at 11:30 hours on the same day, in the presence of bidder's representatives who choose to attend.
