- A valid PEC registration certificate for the year 2024-25 in the relevant category (Category C6 and above) with specialization code is required.
- ii. Bidding documents will be issued in person to government contractors/firms upon the presentation of the following original documents: CNIC, PEC registration, and renewal fee receipt for 2024-25 from the Works Department GB. Please note that all documents must be original.
- iii. Only Project specific Power of attorney's will be accepted on the behalf of parent firms/JVs, if provided on judicial stamp paper duly signed and attested by 1st class Magistrate.
- iv. Each Firm/JVs is eligible to obtain bidding document for only one project. Multiple request for bidding documents for different projects by the same firm/JVs will not be entertained.
- v. Contractors/firms must provide 3% bid security in the form of a call deposit receipt (CDR only) in the name of the Executive Engineer, B&R Division GB C&WD Nagar, from any scheduled bank in Pakistan. The CDR should bear the original signature of an authorized person from the concerned bank branch, along with the original bank stamp. Scanned copies of signatures/stamps will not be entertained.
- vi. The bid security must be provided for the department's verification through the relevant bank.
- vii. Bidding documents will not be issued to constructors who have previously delayed awarded projects.
- viii. Bidding documents will not be issued to entities that are blacklisted and involved in litigation with the department. (An original Departmental No Litigation Certificate/No sick Project Certificate is required.
- ix. Conditional bids will not be accepted by the department.
- Unbalanced quoted rates will be handled in accordance with the rules and policies specified in the bidding documents.
- xi. The procuring agency reserves the right to reject all bids or proposals at any time before accepting a bid or proposal, in accordance with Rule 36 of GBPPRA Rules as amended vide SRO dated September 2022.
- xii. The Bidder quoting rates below 10% of T/S Estimate shall be required to provide along with his bid an additional performance guarantee of 50% differential amount (between T/S and Bid) in shape of CDR from any schedule bank of Pakistan. In case of failure to produce the required differential amount of the bid by the bidder along with bid documents, the bid shall be rejected and security of such bidder shall be forfeited.

xiii. The call deposit to all unsuccessful bidders who participate in the tendering process will be released after expiry of bid validity/
formal approval of tender.
