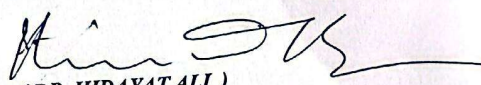

- If the schedule date has declared as local holiday the next working day will be the date of tender opening.
- The rate of each items mentioned in quotation should be computerized: manual rating will not be accepted
- The bidder shall submit affidavit (in original) of not black listing and no court cases of their firm /company.
- All required documents should be attested.
- Bidders for LP of medicines must have medical license for medicine supplies.
- The authority has the power to reject of bid in case of extreme high or extreme low rates. (Irrational rates)
- The bidder will be bound to provide the items missed from comparative statement @ 10% above the Market rate.
- The bidder can be dismissed at any time during the financial year and re-advertised if the bidder do not follow the criteria of supply of items or any other miss conduct.
- In case of delay of financial payments the contractor will not stop the supply of required items.
- Bidders having bad working reputation with this office will not be entertained.
- Attested copy of Form-C and other necessary documents must be attached with the quotation
- Tender copy purchased Fee Rs 2000 not refundable
- In case of Local Holiday, the bidding process will be held on next working day on same time and venue.
