- ii. The interested bidders will submit their bids on 23<sup>rd</sup> January, 2025 at 12.30pm which will be opened on the same day at 1.00pm at the office of the Manager Regional Blood Center (RBC) Gilgit in presence of bidders or their representatives.
- iii. The bidders can obtain bidding documents along with Terms & Conditions from Office of the Manager Regional Blood Center (RBC) Gilgit on written request and payments of Rs. 6000/- (Non refundable) on any working day before closing hours. If the day of opening is observed as national or local holiday, the bid will be opened on next working day at same time and venue.
- iv. 4% bid security in the shape of Call Deposit (CDR) from any schedule bank including KCBL in the name of Manager Regional Blood Center (RBC) Gilgit must be accompanied with the tender/bids and the same will remain with this office till successful completion of supplies and expiry of warranty period.
- v. The bidder shall provide color broacher and complete specification of quoted equipments and also provide authority letter from manufacturers /authorized distributors.
- vi. Warranty period will be at least two years. Rates will be inclusive of all relevant taxes.
- vii. The Bids will remain valid till 30<sup>th</sup> June, 2025
- viii. The procuring Agency reserves the right to increase /decrease the quantity or delete the items
- ix. As per GB-PPRA Rules 2022 Clause 39 (b) single stage two envelope bidding procedure will be adopted for this national competitive bidding.
- x. The procuring Agency reserves the right to accept/reject any or all tenders with assigning the reasons thereof.
- xi. Pre-bid meeting will be held 07 days before opening of technical bids i.e 16-01-2025 (not mandatory)
