- The interested bidders will submit their bids on 07-01-2025, (Tuesday) at 11:30 AM which will be opened on the same day at 12:00 PM in the Conference Hall of PHQ Hospital Gilgit in the presence of bidders or their Authorized representatives. If the day of bid opening is observed as local or national holiday, the bid will be open on next working day on same time and venue.
- The bidders shall obtain bidding documents along with Terms & Conditions, specifications and guidelines from the Development Section of PHQ Hospital Gilgit on written request and payment of Rs. 7,000/- (Non-refundable) on any working day before closing hours.
- 4% bid security in the shape of a Call Deposit (CDR) only from any scheduled bank, including Karakorum Cooperative Bank Limited, in favor of Medical Superintendent PHQ Hospital Gilgit must accompany the tender documents/bids. The CDR will remain with the Procuring Agency until the successful completion of bidding process and award of contract. The bidder shall provide a clear color brochure and complete specifications of the quoted equipment/model/brand in the form of compliance sheet, otherwise the bid will straight away be rejected.
- An authority letter from Manufacturers/Authorized distributors must also be provided with the technical bids for verifications.
- The bid will remain valid till June 30<sup>th</sup>, 2025.
- · Rates will be inclusive of all relevant taxes.
- As per GBPPRA Rules 2022 Clause 39(b), a single-stage two-envelope bidding procedure will be adopted for this National competitive bidding.
