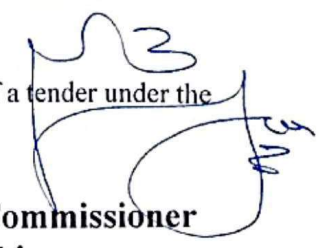

 - a. Separate sealed envelope of tenders for each category may be submitted till 10:00 hrs of the date of opening of tender as mentioned above which will be open on the given date and time in presence of the contractors/suppliers, or their authorized reps who are willing, to be present there.
 - b. Name of category must be written in bold on the sealed envelope.
 - c. A firm/contractor/supplier may offer tenders for one or more or for all categories.
 - d. The sealed envelope of tenders must contain the following documents, without which the tender will be liable to be rejected:
 - a) Tender on the Firms letter paid with vendor number.
 - b) Call deposit worth to **Rs.10000/-** from a scheduled bank.
 - e. The rates of items if not covered in the "**Tender Form**" will be determined in accordance with the retail price fixed by the Chairmen Price Control Committee Shigar.
 - f. Government taxes applicable (if any) will be borne by the Firm/Contractor/Supplier.

Note: The Procuring agency may reject any or all bids at any time prior to the acceptance of a tender under the provision of PPRA Rules.
