- a. Tender form shall be issued to the Govt. Contractors in person on production of original CNIC, PEC certificate valid upto June 2025, renewal fee receipt 2024-25 and CDR.
- b. Contractors /Firms Shall provide 2% E/Money of estimated cost in shape of deposit at call in the name of Executive Engineer (Bridges & Roads) Division Gilgit from any schedule bank of Pakistan.
- c. Tender documents shall not be issued to contractors, involved in litigation with any Govt. organization or heaving sick / delayed projects.
- d. Contractor / Firm shall provide certificates of no litigation, no any sick project with works Department as well as other Government Department.
- e. In case of rates quoted below 10% of estimated cost shall be required to provide alongwith bid an additional performance guarantee of 50% of the differential amount (between estimated cost & bid cost) in shape of CDR/Bank Guarantee from any schedule Bank.
- f. Conditional tender will not be accepted / entertained.

Note: The Procuring agency may reject any or all bids at any time prior to the acceptance of a tender under the provision of GB PPRA Rules.
