- d. Conditional tender will not be accepted.
- e. No tender will be sold on the date of opening of tender.
- f. Bid received after due date & time should not be considered.

Bidding document can be collected from the Office of the Executive Engineer Civil Engineering Division W&P Department Gilgit-Ghizar on cash payment (non-refundable) during office hours by submitting written application along with CDR, original/valid PEC registration certificate in person, original PEC certificate.
