- i. PEC valid registration for current financial year (2025-26) in relevant category and code and must Experience in civil work.
- ii. Latest affidavit of No litigation and No blacklisting for current financial Year (2025-26).
- iii. In case of JV, JV agreement on proper format duly signed by all partners of JV, clearly mentioning share of each partner and lead partner duly attested by Magistrate 1<sup>st</sup> class.
- iv. If a bidder's quoted cost is 10 or less than ten percent (10%) of the estimated cost, 100% (percent) of the difference amount must be submitted as additional performance security in the form of a Call Deposit Receipt (CDR) from any scheduled bank/ KCBL, made in the name of Executive Engineer, Works Division Education Department Gilgit. This additional performance security must be attached with the financial bid. Failure to attach the required security or submission of an insufficient amount will result in rejection of the bid. The bidder having Bid price lower than 25% T/S Cost would be rejected.
- v. Only one tender form shall be issued per contractor/ firm. Contractors who already have projects with less than 75% physically progress will not be issued a tender form, if any delay/issue form department side i.e. site issue, court case, modification/revision of the project the 75% physical progress clause would be exempted.
- vi. Complete set of bidding documents with detailed criteria for qualification and evaluation, BOQ and specification can be obtained from office of the Executive Engineer Works Division Education Directorate of Education Gilgit from date mentioned above upon submission of application with mandatory documents.
- vii. Pre-bid meeting will be held in the office of the Executive Engineer Works Division Education DoE Gilgit for all above work if requested by promising contractor or by the employer.
- viii. Bidding document shall only be issued to the bidder or their authorized representative on production of his/her original CNIC having valid registered power of attorney in original attested by Magistrate 1<sup>st</sup> Class.
- ix. No bid shall be accepted beyond closing time as mentioned above against each work.
- x. In case of Gazette holiday/local holiday, Bid/tender shall be opened on next working day without further intimation.
- xi. The competent authority reserve right to reject any or all application/bid prior acceptance of the application/ bids as per GB PPRA Rule 2022 under clause -36(1).
- xii. Quoted rates by contractors should be typed, hand written rates will be rejected.
