Water Management & Irrigation Secretariat GB received an application contractor/Firm "**JV of M/S Janan & Sons (SMC-PVT), M/S Niamat Wali Lashari & Brothers and M/S Alamuddin**" for redressal of the grievances raised against technical bid evaluation process of above noted project. The Secretary Water Management & Irrigation GB vide Notification S-WM&I-D(2)/2025/1762 dated 17th April, 2025 constituted Grievance Redressal Committee comprising of the following officers (copy attached as **Annex-A**): -



- Notice issued for inviting Technical Proposals from interested Firms through wide publicity in Newspaper & PPRA vide their Notice No. DDWM-HN-ADP-Accts-2(1)2024, dated 18th March, 2025.
- In response of that advertisement 08 Nos Firms submitted their technical and financial proposals to participate in the bidding process and the procurement committee were opened the technical bids in presence of the bidders and 01 Nos of the firms/ bidders were qualified by Procurement Committee.
- The Technical Bid evaluation report prepared and signed by the procurement committee, approved by Deputy Director Water Management & Irrigation District Hunza as Chairman procurement committee and subsequently uploaded in PPRA web site vide PPRA Ref No. **TSE-20250411895**. (Copy attached as Annex-B)

01 No aggrieved bidder Namely **"JV of M/S Janan & Sons (SMC-PVT), M/S Niamat Wali Lashari & Brothers and M/S Alamuddin"** approached/filed complaint to the PAO against the Technical Bid evaluation report. The competent authority constituted GRC vide above referred notification.

PROCEEDINGS:

"JV of M/S Janan & Sons (SMC-PVT), M/S Niamat Wali Lashari & Brothers and M/S Alamuddin"

On the basis of the applicant reservations, the GRC has thoroughly examined the technical bid documents of the **JV of M/S Janan & Sons (SMC-PVT), M/S Niamat Wali Lashari & Brothers and M/S Alamuddin** and observed the following facts and findings:


FACTS & FINDINGS:

As per NIT & Qualification Criteria given under section 3.3 (A)

- 1. The Lead Partner shall not less than 60% of all qualifying criteria*
- 2. Each of Partner shall meet not less than 40% of all qualifying criteria*

The technical proposal of each lead and Associate members were checked thoroughly and found that the Lead Partner **M/S Janan & Sons (SMC-PVT)** has qualified in all categories.

The Associate member **M/S Alamuddin** has qualified in two categories i.e General Experience and Personal Capabilities but failed to qualify the remaining 02 categories i.e capability of machinery and financial soundness.



The 2nd Associate member **M/S Niamat Wali Lashari & Brothers** has qualified 03 categories namely General Experience, Personals Capabilities and Financial soundness but the 2nd Associate members has failed to qualify category of Machinery capabilities. The detail marking evaluation sheet of GRC is attached **Annex-C**


RECOMMENDATIONS

1. As per re-evaluation of the GRC the bidder namely "**JV of M/S Janan & Sons (SMC-PVT), M/S Niamat Wali Lashari & Brothers and M/S Alamuddin**" has failed to obtained the 40% of all qualifying criteria by each associate members under the sub-category of **Equipment capabilities** and **Financial Soundness**, hence the decision of tender evaluation committee is hereby up held for disqualifying the firm for further financial bidding opening and other necessary proceedings.

The tender opening committee may proceed further necessary actions strictly as per PPRA rules.
