- Sealed tenders may be submitted to the undersigned on or before the date mentioned against each category by 12:00 hours, which will be opened on the same day at 12:30 hours in II. presence of the Contractors/Suppliers or their authorized representatives at LG & RD
- Tender with incomplete supporting documents shall not be accepted, and furnishing of incorrect information shall be liable to legal action. III.
- Items must be delivered to this office after issuance of Supply Order from LG & RD IV.
- An affidavit on stamp paper must be accompanied with the tender documents to the effect that the bidder has never been blacklisted by any Government/Semi-Government PPRA. V.
- The rates offered in tender shall be affected till 30th June, 2026. VI.
- The contractor must have its own shop/workshop to participate in the tender. VII.
