2. Bidding documents can be obtained by the interested and eligible bidder on submission of application and non-refundable tender fee mentioned above against each work. The tender fee will accepted through Treasury challan on account of cost of tender form clearly showing name of contractor/work duly passed/endorsed by NBP Skardu Branch in the relevant head of account G-10407 remittance.

The said application shall be mandatory and accompanied by the following documents.

MANDATORY CONDITIONS: -

- i. PEC valid Registration for CFY (2024-25) having relevant code and category.
- ii. Renewal receipt of registration with GB-C&WD for CFY (2024-25).
- iii. Enlistment receipt with procuring Agency (C&WD).
- iv. CNIC of the prospective bidder/ firm/ JV.
- v. No. Litigation Certificate No Black Listing Certificate and No Sick Scheme Certificate issued by Chief Engineer C&W Department -Baltistan Region Skardu and Affidavit of No delayed project in hand duly attested by 1st class Magistrate.

TERMS & CONDITIONS:-

- 1. The bidding documents will be issued to firms/contractors after scrutiny of documents by the committee and upon submission of 2% bid security in shape of CDR issued by any schedule bank in Pakistan. The contractor / owner of the firm must collect document in person.
- 2. Rates quoted below 10% upto 25 % of the Technical Sanction shall be required to provide along with his bids an additional performance guarantee of 50% of the differential amount (between TS and Bid) in shape of CDR from any schedule Bank of Pakistan ,that shall be verified during the evaluation of bids rates below 25 % of T/S shall be rejected.
- 3. No bid shall be accepted beyond closing time as mentioned against each work.
- 4. In case of Gazette holiday/local holiday/surprise engagement, tender shall be opened on next working day without further intimation at same time.
- 5. Bids shall be opened in the office of the Executive Engineer B&R Division C&WD Skardu.
- 6. The contractors debarred by any Region/Division and notified by Works Secretariat shall not be eligible to participate in the bidding process.
- 7. The bid security of unsuccessful bidders shall not be released before the issuance of work order to the successful bidder.
- 8. Power of Attorney shall not be accepted and original contractor must collect the tender form and must be present in the procurement process.
