- 1. Sealed quotation should reach in the office of Deputy Director Agriculture Gilgit, KIU road Gilgit on or before 26-09-2024 at 10:30 hours and will be opened on the same date at 11:00 hours in the presence of bidders or their representatives.
- 2. Quotations shall be accompanied with 3% of the total offered rates as bid security in the shape of Call Deposit Receipt (CDR) issued by scheduled banks and KCBL in favor of the Deputy Director Agriculture Extension Gilgit.
- 3. Detailed Tender documents can be obtained during office hours after publication of Tender Notice on cash payment of Rs. 2000/= as tender fee.
- 4. Rates will be evaluated on lot basis.
- 5. The supplier must mention the lot Number and name clearly on envelop for which they applied.
- 6. The Firm/Bidder must have relevant experience of two years i.e. Completion certificate/Supply orders of similar nature work.
- 7. The Supplier must quote the rates of all items otherwise the bid shall be considered non responsive
- 8. Unrealistic rates i.e. over or under estimated shall be rejected straight away.
- 9. The quotation without call deposit or after due date shall not be entertained and Conditional quotations shall be treated as non responsive.
- 10. Items will be purchased according to the availability of funds. The quantity of items can be enhanced/reduced or deleted in the public interest.
- 11. Single Stage Two envelope will be adopted. The financial bid of only technically qualified bidders will be opened.
