- Contractors /Firm shall provide the latest Certificate of No Litigation/No Sick Projects with any other Government Departments (attested by ist class magistrate).
- The Contractor who quoted Tender rates more than **10%** Percent Below of T/S Cost shall be required to Provide along with bids an additional performance guarantee of 50% of the differential amount (between TS and bid) in shape of CDR From any Schedule bank of Pakistan. In case of failure to produce the required differential amount of bid by the bidder along with his bid documents Shall be rejected.

- Conditional Tender will not Accepted /Entertained.
